(6/15) **COVID Compliance Affirmation** – New York State has issued new guidelines for churches planning to hold worship services, including funerals, in their buildings. In order to reopen, churches are required to electronically affirm they understand and will comply with these guidelines. Churches are also expected to create a compliant business safety plan to be kept on file at the church. There are (2) affirmation forms to be completed – one for NYS and one for UNY. **Please note that these need to be completed even if you are not meeting in your building!**

The 2021 Clergy Compensation Package information has been emailed to the Staff Parish Pastor Relations Committee (SPPRC) chairs for those churches which have provided contact information. Pastors have been emailed the materials and local church treasurers have been advised where to obtain the basic information contained in the packet. The United Methodist Discipline directs the SPPRC to consult with pastor and staff regarding all aspects of compensation and to then recommend appropriate proposals to the Church Council prior to the Charge Conference; and/or on an annual basis.
